## THE INTENSIVE LANGUAGE, LITERACY, AND AUDITORY PROCESSING CLINIC

Children who have difficulty with speech, language, or hearing (auditory processing) often have difficulty learning to read, write, and spell. This program is designed to address underlying language, literacy, and processing skills necessary for academic and social success.

The following areas may be addressed, dependent upon individual needs: auditory processing, phonological awareness, oral discourse, receptive and expressive language (vocabulary and grammar), word finding, reading, writing, and spelling. This program promotes the development of skills, compensatory strategies, and self-advocacy.

Child must demonstrate the ability to productively take part in a small group for 2.25 hours. Child may be discharged if unable to participate.

### THE INTENSIVE STUTTERING CLINIC

Over three million Americans stutter, approximately 1% of the population. The impact of stuttering can exceed its severity, thus affecting a child's selfesteem, school success, social wellbeing, and life. As such, the main focus of therapy targets stuttering acceptance and advocacy. Our message remains consistent: It's okay to stutter. In addition, the SUNY Buffalo State Intensive Stuttering Clinic incorporates Stuttering Modification and Fluency Shaping Therapy approaches.

#### **Program Goals:**

- Enhance acceptance and understanding of speech and stuttering to diminish the negative consequences or impact
- Manage and modify stuttering and associated behaviors
- Improve communication and more speech spontaneity

**Family participation** is vital to the success of the program and is encouraged. One to two parent group meetings will be hosted as an avenue for learning and open discussion.
